1. Minutes from 08th May 2017 Meeting

Vincent McCabe requested the minutes be amended to state "Vincent McCabe proposed the Forum invite Dublin Bay Studios to give a presentation to the Forum".

2. Presentations

Emer Costello MBA gave a presentation on Stakeholder Engagement

Following the presentation a discussion by the members ensued and a number of comments were made:

- Failure to implement effective consultation/ decision making stakeholder networks with the power to ensure planed/promised delivery of housing, social and commercial infrastructure lead only to negative results for the community.
- Members found the presentation very interesting and relevant and requested a full transcript of Emer Costello's Stakeholders Engagement thesis for the Forum members.

Jamie Cudden of the Smart City office DCC gave a briefing on a Smart City Forum engagement Proposal

• It was agreed the Forum would work with the Smart City office and Jamie is to contact the members directly with details of a Smart City workshop in September in which members can participate.

Terre Duffy of Water Ways Ireland gave a presentation on Water Ways Ireland's plan for the Docklands water ways.

The following comments were made by the members:

- Limits on the security of tenure, restricts the option of living on the water in managed mooring sites.
- Anti social behaviour associated with the water ways should be channelled and offenders worked with, outreach groups and partners groups should be set up.
- Water quality needs to improve.

Myles Farrell DCC A/Senior Planner, gave a progress report presentation on North Lotts/Grand Canal Dock SDZ & Poolbeg West SDZ.

Following the presentation members requested the following:

- that future reports should show a breakdown of the Social Housing units to be delivered and the levels of Local Employment.
- that more time is spent on discussing planning/SDZ issues and less on presentations.

3. AOB

Dermot Lacey and Dolores Wilson requested an increase in representation for community groups on the Forum particularly from Ringsend and for this request to be conveyed to the Minister.

*The Forum considered it appropriate to await the finalisation of the Poolbeg West SDZ process before a request for a presentation by Dublin Bay Studios be dealt with.

In describing the Dublin Bay Studios request to use Dublin Port Company lands Mr. O'Reilly used the term land grab. Mr. McCabe objected to the use of the term in this case.
